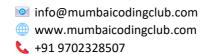
1. Information We Collect

2. How We Collect It

- **Directly from you:** forms, uploads, emails, chat, phone calls.
- Automatically: via cookies, server logs, and similar technologies.
- **Third-party sources:** payment gateways, background-check partners, recruiters, or social-login providers.

MCC uses Google Analytics and Facebook/Google ad services for usage statistics and retargeted ads. You may opt-out of Google Analytics via the Google Ads Settings page or install the Google Analytics Opt-out Browser Add-on.

4. Sharing & Disclosure

We never sell your personal data. We may share it only with:

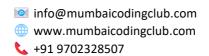
- Internal MCC staff & mentors to deliver training and support.
- Placement partners / recruiters strictly for shortlisted, eligible students.
- Service providers cloud hosting, email, payment processors, analytics, all bound by NDAs.
- Government or law-enforcement bodies when compelled by applicable law or to defend MCC's rights.
- Prospective investors or auditors only aggregated or anonymised reports.

5. Cookies & Tracking Technologies

We use:

- Essential cookies login state, CSRF protection.
- Performance cookies traffic metrics via Google Analytics.
- Advertising cookies Facebook Pixel, Google Ads Remarketing.

Most browsers let you refuse or delete cookies; the Portal may not function optimally without them.









6. Data Security

MCC employs industry-standard safeguards such as TLS encryption in transit, AES-256 encryption at rest, role-based access controls, and regular security audits. Users must protect their passwords and notify us of any suspected breach.

7. Data Retention

We keep your records:

- Academic & placement data: 7 years after course completion (regulatory & accreditation purposes).
- Financial data: 8 years (tax laws).
- Marketing consents: until you withdraw consent.
- Server logs: 12 months, unless required longer for security investigations.

8. Your Rights

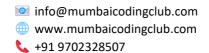
Depending on your jurisdiction, you can:
